Minutes of the Arena Committee Meeting Held Wednesday, December 13, 2017

Special Arena Committee Chair, Councillor King, called the meeting to order at 7:50 a.m.

- 1. Introductory Remarks:
 - The Chair advised that on December 12th, 2017, Council had provided the Committee with an extension of time to March 31, 2018, to bring recommendations forward to Council.
- 2. Adoption of the Agenda:
 - The Agenda was adopted as presented.
- Minutes:
 - The Minutes of the November 22, 2017 were approved and will be presented to Council on January 16, 2018.
- 4. Site Selection Analysis Presentation Provided
 - (i) Memorial Gardens/Thomson Park John Severino went through the presentation
 - If Memorial Gardens is the preferred location can the parking and traffic issues be overcome? How long would it take to do a detailed traffic study?
 - o Parking will be issue with a new arena development
 - Traffic and Parking issues cannot be eliminated
 - Detailed traffic impact study would need to be completed to identify future impacts and potential mitigation measures to reduce the negative impacts. They will not be eliminated.
 - We would have to hire a consultant would want to wait until the location is chosen.
 - Have any of the Expert Engineers ever considered blowing out a wall at the YMCA to connect the arena?
 - We did not look at the site carefully when the geotechnical work was completed since the addition has always been to the current facility
 - Does Class D mean that is not an acceptable location?
 - No, but it does trigger additional building costs.
 - There possibly could be another route which would not spill out on Fisher Street but in another direction.
 - It is assumed and would need to be confirmed through the Traffic Impact Study
 - There are site start-up costs vs. operations costs. Do we have those comparisons for the two sites? There should be significant savings in Hydro with the new system that will be in place?
 - There would be a reduction in heating costs.
 - o Electricity agreement will likely be at market rate
 - Could you please elaborate on what you mean by potential control issues?

- o That would be in relation to concessions depending if they are going to be built in the new arena or left in the existing building.
- Some other issues that we see with the build at this area are:
 - There would need to be a redesign of the Kinsmen Trail as this has linkages from both directions.
 - Loss of sports fields and park space
 - Would need to relocate the Football and Baseball fields.
 - Rollie Fisher Field has major soccer tournaments and ultimate Frisbee.
- What is the utilization of the field?
 - Bulldogs three times per week. There are options to go to schools or Omischl Field.
- When there are game days/special events there will be traffic impacts into the residential area.
- (ii) Omischl Sports Field John Severino went through the presentation
 - There is plenty of room for expansion at this location.
 - What are the current parking spaces at Omischl vs. Memorial Gardens?
 - o We will get that information for you
 - o Intent would be to optimize parking for year round use at Omischl
 - Are there ATV or snowmobile trails that go through this property?
 - o The trails do not go through the property but they are close.

(iii) Other Sites

- Where are we at with the RFP Procurement process?
 It will be ready in the New Year.
- Can't really make a decision until we see all of the private proposals.
- This Committee would make a recommendation regarding the municipally owned property and once staff has had an opportunity to review all of the private proposals they would bring a report to Council with a recommendation.
- 5. Recommendations to Council:

That the Arena Committee bring forward a recommendation to Council recommending Omischl Field as the preferred municipally owned location for the new Arena.
